GENERAL WARRANTY DEED

WHEREAS, the descendants of Jane Poindexter Clingman and Dr. Alfred Jones have functioned as an unincorporated association known as the "Clingman-Jones Family Reunion" (the "Association") since 1923 in the ownership, possession, use, and management of the approximately 200 acre tract herein conveyed ("Jones Valley"); and,

WHEREAS, the undersigned are the currently elected and serving officers and directors of the Association; and,

WHEREAS, the undersigned, on behalf of the entire family (collectively "Grantor"), have formed an Unincorporated Nonprofit Association ("Grantee" herein) denominated the "Clingman-Jones Family Association" pursuant to the Revised Uniform Unincorporated Nonprofit Association Act as found in A.C.A. §4-28-601, et seq and in accordance with A.C.A. §4-28-631 wish to convey all right, title, and interest in and to Jones Valley to the Grantee.

THEREFORE, the undersigned being all of the duly elected and acting officers and directors of the Association, for and in consideration of the sum of \$10.00 and other good and valuable consideration in addition to the love and affection held by the Clingman-Jones descendants for one another and in order to maintain and preserve the heritage of, and as a living legacy of, the founding descendants, in hand paid by Grantee, the receipt and sufficiency of which is hereby acknowledged, do hereby grant, bargain, sell, and convey unto the Grantee, and unto Grantee's successors and assigns forever, the real property situated in Montgomery County, Arkansas, described as follows (the "Property"):

The North One-Half of the Southeast Quarter (N/2 SE/4) of Section 18, Township 4 South, Range 24 West and the North One-Half of the Southwest Quarter (N/2 SW/4) and the Northwest Quarter of the Southeast Quarter (NW/4 SE/4) of Section 17, Township 4 South, Range 24 West, Montgomery County, Arkansas, (commonly known as "Jones Valley").

TO HAVE AND TO HOLD said Property unto Grantee and unto its successors and assigns forever, with all appurtenances thereunto belonging. And Grantor hereby covenants with Grantee as follows:


