~ Valley News, Reunion 2018 Recap and Beyond ~

- Cameron Cabin Construction The fall of 2017 was marked by the breaking ground of the new Cameron Cabin, with JJ putting his architectural design and building talents to bear on the Valley's latest addition, abetted by Cameron cohorts Milton, Jeff, Patrick, and Don Engel to just name a few. The cabin is nestled in the pines just off the open field to your left as you drive into downtown Jones Valley. It is an innovative two story structure with five family rooms that sleeps 25. Work continued on every long weekend available thru 2018 and it is expected to have the exterior completed in time for this year's Reunion at which time the cabin will be christened the "Five Brothers." Way to go, Cameron Clan!
- New Swimming Hole Sit-Out Deck – At Larry Braswell's (Fannie Line Representative) urging, vour Board members jointly funded construction of a deck overlooking swimming hole – a great place to watch the swimming hole goings on, especially the annual Inner Tube Contest. was a big hit, and got a 2018 lot ofReunion Thank usage. vou. Larry, for the idea and

➤ Family Business Meeting – President Spencer Cubage warmly welcomed everyone to the 97th Clingman-Jones Family Reunion. Major items covered at the meeting included:

Controlled Burn – Spencer informed the meeting that for safety purposes and responsible forest management, a controlled burn of Jones Valley by the Arkansas Forestry Department was planned. This of course would not include the main cabin area or the area close to Nelson's and Micah's cabin. Spencer asked Kelly Jobe to explain in more detail the benefits of this action. Kelly mentioned the care that the Forestry department takes in their work and explained how a burn protects the woods. Mike White, Secretary/Treasurer, mentioned that the Family had received a grant from the USDA to pay for the Control Burn, so there would be no cost to the Family.

<u>Legal Update</u> – On October 25, 2018, the lawsuit that Priscilla Diffie Couch brought against the Family Board and several individual family members was tried before Judge Jerry Ryan in the Mt. Ida courthouse.

On February 26, 2019, Judge Ryan issued a letter order in which he held that he could not decide the dispute unless everyone with an interest in Jones Valley were added as a party to the lawsuit. In essence, Judge Ryan will not permit Priscilla Diffie Couch's case to proceed until she notifies and/or sues every living Clingman-Jones lineal descendent and his or her heirs. The Clingman-Jones lineal descendents alive today are estimated to include many thousands of people throughout the United States and the world.

The judge's ruling closely follows the reasoning of one of the Family's early motions in the case which requested that Judge Ryan dismiss the case because Priscilla Diffie Couch's claims would affect the interests of numerous Family members and could not be fairly decided in their absence. Though Judge Ryan initially denied that motion as premature, he gave the Family the opportunity to re-file the motion later. Having heard all the evidence presented at trial, the judge now agrees with the Family's position that all Family members must be "afforded the opportunity to be represented and respond" to Priscilla Diffie Couch's lawsuit.

To date, Priscilla Diffie Couch's lawyers have not responded to the judge's February 26 ruling. Nor have they filed anything to indicate whether Priscilla Diffie Couch will continue pursuing her case following that ruling.

Three months prior to the trial, this lawsuit was discussed as an agenda item of the June 30, 2018 Family Business Meeting. Among other things, the Legal Committee explained that Priscilla Diffie Couch's lawsuit challenges the actions the Board took in 2015 to transfer title to Jones Valley into the Clingman-Jones Family Association, an Arkansas unincorporated nonprofit association formed for the express purpose of holding title to Jones Valley.

At that 2018 Family Business Meeting, the Family voted on whether to support the Board's 2015 actions of 1) adopting the unincorporated nonprofit association legal entity, and 2) transferring the deed to Jones Valley to that entity. This vote was taken, because Priscilla Diffie Couch previously stated in sworn testimony that she would have accepted the Board's 2015 actions if the Family had been given an opportunity to vote on whether to support them. After the Legal Committee's explanation and all questions had been answered, the Family voted unanimously in favor of the Board's 2015 actions. Despite the Family's unanimous vote in support of the Board, the lawsuit was not dismissed.

<u>Open Family Discussion Time</u> – After the meeting agenda items were covered President Cubage opened the floor for general discussion. The Family members freely discussed several items, including Karl Bowman's concern about water seepage under the dam. Spencer said this would be investigated next time the swimming hole was drained.

Robert (Bob) Aronson - Mary Line (February 17, 1939 - October 11, 2018)

Bob and Robin Diffie Aronson attended many a Reunion, as they scheduled it as a special stop on their travels to summer festivals connected with Robin's art. Due to health challenges, Bob's mobility was limited, but not his interest in his family and country.
